

Interviewer: I'm here today with attorney Christopher Glinski. Attorney Glinski, how did you start your legal career?

Milwaukee Defense Lawyer Christopher Glinski: I started my legal career prosecuting cases at the Milwaukee County District Attorney's Office. The job of a prosecutor is to put the bad guys in jail. But the more cases I prosecuted the more I realized that a lot of the people I was putting in jail were not bad people. They were often good people who had gotten themselves into trouble and needed help. So over time I decided that I would rather use my skills and talents and experience to help people rather than put them in jail and that's when I became a criminal defense attorney.

Interviewer: What can you offer that most attorneys can't?

Milwaukee Defense Lawyer Christopher Glinski: Well, if you call me I offer a free consultation. At that consultation we'll sit down and we'll go over your case. We'll talk about any defenses you may have and I'll walk you through the entire process step by step and I'll tell you what to expect along the way. I'll also provide you with my cell phone number. That way you can call me if you ever have any questions and I'm available around the clock. I really enjoy being available to my clients around the clock because I find that clients tend to have a lot of questions during the process and when they can call their attorney at any time and ask questions it really puts them at ease and makes the process more comfortable. In addition, by giving you my cell phone number you won't have to call my secretary, you can if you want to, but you won't have to call my secretary and hope that you can get through to me. You can call me directly and I'll be happy to answer any questions you may have.

Interviewer: Do you have any trial experience?

Milwaukee Defense Lawyer Christopher Glinski: I do have trial experience. I've tried over a dozen cases as a defense attorney. I've prosecuted cases as well at the Milwaukee County District Attorney's Office. And through that experience I learned how prosecutors think. That's one thing I bring to your case that's a huge advantage: knowing how the prosecutor on the other side is thinking. Also, I learned that prosecutors know which defense attorneys will take cases to trial and which defense attorneys won't take cases to trial. And believe me when I tell you that the defense attorneys who take cases to trial get much better deals from prosecutors than defense attorneys who don't take cases to trial. So my trial experience is something that I bring to your case and will be a huge advantage to you in getting the best possible outcome for your case.

Interviewer: What makes you most proud to practice law?

Milwaukee Defense Lawyer Christopher Glinski: What makes me most proud is when I get phone calls from potential clients saying "Mr. Glinski, we've called a number of attorneys and we feel most comfortable with you. Will you please take our case?" And I think people feel that way because I sit down with them. I take a personal approach to my clients; I care about their cases. And I fight hard for them. I like to walk them step

by step through the case, answer any questions they may have, and I think that really puts them at ease.

Interviewer: Do you offer any services other than criminal defense?

Milwaukee Defense Lawyer Christopher Glinski: I have. I've expanded my practice to include immigration law, estate planning law, and family law as well. I've taken the skills and the experience that has made me a successful criminal defense lawyer and have applied those to these other areas. And in the family law area I handle child custody issues and I also handle divorce cases.
